**HOLDING DEPOSIT**

(d) Despite sections (b) and (c) the holding must not be retained by the landlord if the

tenant refuses to enter into the residential tenancy agreement because of a

misrepresentation or failure to disclose a material fact by the landlord or landlord's

agent.

(e) The Holding Deposit will be banked into NOTICE TO ALL TENANCY APPLICANTS Carmen's Property Management Trust account which will be provided upon acceptance.
